SUBMISSION DATES

Production ready advertisement content is due, no later than, the first of the month proceeding publication. For example, for advertisements in our December issue, ad content must be submitted no later than November 1st.

AD DIMENSIONS

Maximum dimensions:

Full Page = 8.5" w x 11" h

Half Page Horizontal = 8.5" w x 5.5" h

Half Page Vertical = 4.125" w x 11" h

Quarter Page Horizontal = 8.5" w x 2.69" h

Quarter Page Vertical = 4.125" w x 5.5" h

Eighth Page Horizontal = 4.125" w x 2.69" h

BLEED SIZE

Vital matter on bleed advertisements should be held 1/2" from the trim edge. Bleed trim is 1/4" at head, outside and at foot. All material requiring cropping should be accompanied by a proof indicating trim and positioning of advertisements. Unless otherwise specified, material will be positioned (centered) in the space ordered.

GUTTER ALLOWANCES

No allowance is necessary. Printer will line up allowing for backbone trim off. To assure proper gutter bleed allow 1/8" for grind off.

MATERIAL/FILE SPECIFICATIONS:

All RGB and spot colors should be converted to CMYK. PDF, EPS, TIF, and JPG files are all accepted. TIF and JPEG ads must be submitted at 300 dpi. Only one ad per file should be included on any of the above media.

Account is delinquent after 30 days. Delinquent accounts are subject to a 1.5% service charge. Minimum charge on delinquent accounts is 50 cents per month. No agency commissions are allowed.

CANCELLATIONS. All cancellations must be received in writing prior to the submission deadline. If the contract is not fulfilled, the space purchased will be re-billed to the advertiser at the dollar volume level actually incurred, according to the rate schedules in effect when the advertising was published.
